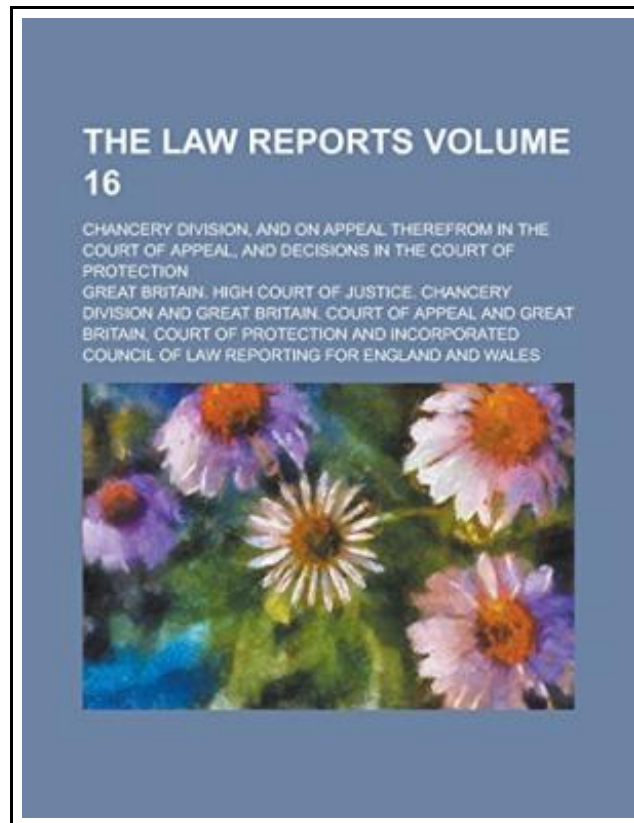

The Plaintiffs claimed an order that the Defendant should specifically perform his agreement of the 20th of March, 1878, as modified by the agreements of the 14th of November, 1879, and the 19th of January, 1880, by delivering up to Stevens the manuscript of Kermy s Illustrated London, and by doing all acts necessary to vest the copyright of the work in Stevens; an injunction to restrain the Defendant from parting with or publishing, or otherwise dealing with, the work or the copyright thereof, without the Plaintifl s consent; damages for breach of the agreement; and the costs of the action. By his statement of defence the Defendant said that in March, 1878, prior to the written memorandum of the 20th of March, it was verbally agreed between him and Post that, in consideration of 200 to be paid to him, the Defendant should write an original guide-book for London, and that his name should appear on the title-page as the author of the book, and that he should assign the copyright of the book to Post. But throughout the conversation in which the agreement was come to, no mention was made of the name of Kenny, nor was the Defendant informed or aware...
